**Public Works & Engineering/Construction  
Inspection Permit Fees**

**Public Works**

- Utility Providers, Contractors and Vendors occupying or working within City ROW, Easements or City owned property are required to obtain an approved Public Works Permit as well as pay permit fees as outlined below.
- Minimum \$75 administration fees for all Public Works permit applications.
- Performance/Surety Bond (Full Construction Cost Valuation):  
All Public Works permit applications must be accompanied by a performance bond certificate listing the City of Litchfield Park as the holder or cash deposit equal to the valuation of the construction items proposed. The valuation shall be estimated from a sealed Engineers Opinion of Probable Cost Estimate approved by the City Engineer, using current construction unit rate and general condition costs. No Public Works applications will be processed or approved without this bond in place.

- Pavement Restoration/Cut Fees (In Addition to all other permit fees):

**Engineering and Inspection**

- Minimum \$75 Administration Fees for all Engineering Permit Applications.
- Engineering Permit Fees are included in the Engineering Plan Review Fees.
- Construction Inspection Fees (3% of Construction Costs):  
Inspection fees are required for all work within City ROW, Easements or owned property, as well as private development projects that include civil & utility improvements. Fees are estimated from a sealed Engineers Opinion of Probable Cost Estimate approved by the City Engineer, using current construction unit rate and general condition costs, or as otherwise approved by the City Engineer.
